Dear Consumer:

This is to introduce the **New York Prescription Saver** – a free drug discount card that can help New Yorkers save as much as 60 percent on generic and 30 percent on brand name drugs right at the pharmacy counter! The discount card is sponsored by New York State and is accepted at most pharmacies across the State.

To enroll in New York Prescription Saver (NYPS), residents must be either age 50 to 64 or determined by the Social Security Administration to have a disability. The annual income limits for the NYPS card are up to \$35,000 per year for a single person and \$50,000 for married couples. However, if there is a substantial income drop residents may report their current year gross income. Those receiving full Medicaid benefits are not eligible.

Enrollment in NYPS is quick and easy. Individuals can apply directly online at <a href="http://nyprescriptionsaver.fhsc.com">http://nyprescriptionsaver.fhsc.com</a>, or download a simple one page application from the website and mail it in, or call the toll-free NYPS Helpline at 1-800-788-6917 (TTY 1-800-290-9138), and a representative will complete the application over the phone.

New York Prescription Saver can provide members with excellent discounts on almost all prescription drugs, including insulin, needles and insulin syringes. The New York State Health Department is working with pharmacies and drug manufacturers to provide these discounts to those struggling with high prescription costs.

## Free Drug Discount Card Offered by NYS New York State Working with Pharmacies and Manufacturers to Lower Drug Costs

New York State recently introduced the **New York Prescription Saver (NYPS)**, a free prescription discount card that can help save on the cost of prescription drugs, including insulin, needles and insulin syringes The card is for New York State residents who are 50 to 64 years of age or persons with a disability regardless of age. Income eligibility limits are up to \$35,000 single and \$50,000 married. However, if there is a substantial income drop residents may report their current year gross income. Those with Medicaid coverage are not eligible.

The NYPS card can lower the cost of prescriptions by as much as 60 percent on generics and 30 percent on brand name drugs. When the card is presented, the price will be reduced by a cash discount right at the pharmacy counter. Most outpatient prescription drugs are eligible for a discount. New York State is sponsoring the program with the support of a statewide network of over 3,900 pharmacies that are generously providing these discounts. Many pharmaceutical manufacturers are also participating and providing additional discounts.

Individuals must meet the income requirements and use the card at participating pharmacies. Applicants can apply online at <a href="http://nyprescriptionsaver.fhsc.com">http://nyprescriptionsaver.fhsc.com</a>, download a NYPS application from the website and mail it in, or call the toll-free Helpline at **1-800-788-6917**. Participating pharmacies and the discounted prices for drugs can be found on the website.

The NYPS program has outreach representatives across the State who can provide training to help others apply or present program information to groups.
