Reports

<u>Chair/Vice Chair Report</u> – Oamic Ingredients LLC is looking to open up a storage facility for food flavor additives within Westchester County. The town of North Castle had requested for the LEPC to review the emergency plan and chemical that is to be stored at the new facility and inform the town if they approved of the opening of the site. The facility would be located within a water shed and in close proximity to a child care facility and a local water source.

APTIM, a private firm reached out to verify that Lowe's Home Center in Yonkers had submitted a Tier II report and it was verified that the Tier II was submitted via Eplan.

<u>WC-OEM Rep</u> – OEM has been assisting with canvasing and identifying potential members to fill the vacant seats on the voting membership in accordance with the bylaws that were adopted at the October 2017 Annual Meeting. Historically getting elected officials and media

representation has been challenging.

<u>WC HazMat Report</u> – There has been no big Hazmat event to report this last quarter. Westchester County's HazMat Team is working with ConEdison to conduct a drill later this month at one of their substations. Dutchess and Putnam County will also be participating in the exercise.

WC Health Dept. Rep – Westchester County Department of Health was not present.

<u>Tier II/LEPC Report</u> – The LEPC held three workgroup meetings (in January, April, and July), two conference calls in June, and the annual LEPC meeting. The workgroup sessions focused on setting up three subcommittees to aid with various LEPC activities including gathering a list of candidates to fill the LEPC Membership rooster; planning for the annual meeting; and improving community outreach and communication. The LEPC has also being coordinating and sharing Tier II information with Yonkers Fire Department on a regular basis.

For the 2017 reporting year there was 363 locations that had filed Tier II reports to the LEPC. Of these locations, 334 had filed using E-plan. 29 locations had filed using paper. Additionally there were 15 new filers/locations this year: Equnix LLC – Elmsford FD; Lowe's Home Centers – Yonkers FD; New Cingular Wireless – Yonkers FD; Northwell Health – Sleepy Hollow FD; Target Corporation (3 locations) – Mount Kisco FD, Mount Vernon FD, and White Plains FD; Verizon Wireless – Harrison FD; and Westchester County DEF (7 locations) – Mamaroneck FD, New Rochelle FD, Ossining FD, Peekskill FD, Port Chester FD, Rye FD, and Yonkers FD.

Committee Reports

<u>Nominations Committee:</u> The committee drafted up and sent out letters to both current members and prospective members. Most of the seats were filled and will be presented to the membership to vote on.

<u>Hazardous Materials Advisory Committee:</u> In Spring a four day training was held for the WMD Squads. Following that training was a drill from which the After Action Report has finally been received. The report will be reviewed to see where improvements can be made.

HazMat Annex is also be reviewed and updated with collaboration from various agencies.

<u>Community Preparedness Committee:</u> A letter has been drafted up to be sent out business explaining what the LEPC is and how important it is to file the required Tier II information. The committee wants to investigate having municipal officials or the County Executive's support in this matter.

New Business

<u>Nomination of Members and Vote:</u> Peter McDonough (Chair) opened the floor for any additional nominations for membership and none were made. The LEPC was presented with the list of candidates:
