Re: National Infant Immunization Week April 24- May 1, 2021 "Immunizations: Power to Protect"

Dear Colleague,

This year especially, it is important to assure your infant patients catch up with any immunizations they may have missed due to the pandemic. <u>A CDC report</u> found a troubling drop in routine childhood vaccinations while families stayed home. With COVID-19 vaccination rates increasing, and schools, daycare and society resuming in-person activities, now is the best time to increase protection of your pediatric patients from 14 vaccine-preventable childhood diseases.

National Infant Immunization Week celebrates the achievements of immunization programs in promoting healthy communities throughout the United States. You are an important partner in immunizing infants and educating parents and families about the importance of childhood vaccines, and I thank you for your efforts on behalf of Westchester families.

Another way you can help your patients is to encourage their parents and caregivers to ask their own providers what vaccines are right for them and to encourage them to participate in the New York State Immunization Information System (NYSIIS).
