

ARTICLE XXI. - ADDITIONAL FEES

Sec. 873.2100. - Migrant labor camp application fee.

Every application for a permit or for a renewal of a permit to operate a Migrant Labor Camp pursuant to article XI, section 873.1171, subsection 1, of the Westchester County Sanitary Code shall be accompanied by a nonrefundable application fee ~~\$440~~130.00.

Submittal for written approval to undertake the construction of a separate disposal system other than a single-family residence pursuant to the provision of article VIII, section 873.726 of the Westchester Sanitary Code shall be accompanied by a nonrefundable fee of ~~\$35~~40.00 per 100 gallons of design flow. The minimum fee shall be ~~\$555~~670.00, and the maximum fee shall ~~\$3,465~~4,160.00 for any separate disposal system approval under this section.

#### Licensing of septage removal vehicle, septic system contractors and septage collectors

- An original nonrefundable application fee of ~~\$200~~\$240 per motor vehicle
- Biennial licensed/renewal fee of ~~\$200~~ \$240 per motor vehicle

b) Every application for a permit to license a septic system contractor or a septage collector pursuant to the provisions of Article VII, Section 873.722 of the Westchester County Sanitary Code shall be accompanied by

- An original nonrefundable fee of ~~\$200~~ \$240 per septic contractor applicant; ~~\$100~~ \$120 per septage collector applicant
- ~~\$100~~ \$120 per applicant for initial septic system contractor exam; \$25 for reissuance of exam or renewal exam
- Biennial license/renewal fee of ~~\$200~~ \$240 per licensed septic contractor; \$100 per licensed septage hauler.

*Realty subdivision:* ~~\$210~~250.00 per lot to be served or ~~\$35~~40.00 per 100 gallons of the design flow of a water treatment facility, whichever is greater, with a maximum fee of ~~\$34,650~~41,580.00.

*Other than realty subdivision:* ~~\$700~~840.00 except:

~~Three hundred fifty~~Four hundred twenty (\$420.00) dollars for water main construction or modification up to 500 feet in total length. ~~Thirty-five~~Forty (\$40.00) dollars per 100 gallons of the design flow for a water treatment facility, with a minimum fee of ~~\$350~~420.00 and with a maximum fee of ~~\$34,650~~41,580.00. ~~Seven-~~Eight hundred forty dollars (\$840.00)for minor modifications at existing water treatment facility.

*Realty subdivision:* One hundred ~~forty~~seventy (\$170.00) dollars per lot to be served or ~~\$35~~40.00 per 100 gallons of design flow of a wastewater treatment facility, whichever is greater, with a maximum fee ~~\$34,650~~41,580.00.

*Other than realty subdivision:* ~~Seven-~~Eight hundred forty dollars (\$840.00) except: ~~Three-~~Four hundred ~~fifty~~twenty dollars (\$420.00) for sewer main construction or modification up to 500 feet in total length. ~~Thirty-five~~Forty (\$40.00) dollars per 100 gallons of the design flow for a wastewater treatment facility, with a minimum fee of ~~\$350~~420.00 and with a maximum fee of ~~\$34,650~~41,580.00. ~~Seven-~~Eight hundred forty (\$840.00) dollars for minor modifications at existing wastewater treatment facility.
